As Fulton Shaw has no doubt told you, we are in the process of turning over all affairs pertaining to sale and scheduling of live performances to Keller Breland Associates, Inc. The new organization is made up of George Barnes (advertising manager of General Mills Feed Division), Joe Coulombe (also of General Mills Advertising Department), and Lloyd Ellingwood (Formerly western manager for Scholastic Magazine). These are all men of the highest caliber and integrity and are furthermore easy to get along with. I am sure that you will be able to work out a very practical and fruitful arrangement with Keller Breland Associates for exploring the vast potential of animal acts for rental to fair managements.

Ellingwood, who is vice president in charge of sales for the new corporation, has requested that you and Fulton put together a tentative proposal of how you would operate, including estimated sales volume, pricing system, method of handling and transportation, etc. I am sure that you will find dealing directly with Ellingwood much more satisfactory and efficient than would be the case in dealing with Animal Behavior Enterprises, since arrangements of this sort are his specialty, while mine is the development and production of animal behavior. I am increasingly eager to devote all my time and the facilities of Animal Behavior Enterprises to developmental work; hence the establishment of the sales company and the delegation of functions to it.

With regard to the Los Angeles Fair acts: we are now working on the final props. We decided to alter the conception of the golfing goat act because the distance possible for the ball to travel was too short relative to the sire of the goat. This act is much more impressive and amusing than the golf.

The dimensions for the five acts are as follows:

- 1) Pumping pig: 4 x 8
- 2) Piggy bank: 4 \* x 8 ....
- 3) Goat "Win a Cigar": 3' x 10"
- 4) SureShot, the Basketball Playing Rabbit: 2' x 6'
- 5) Casey, the Baseball Playing Chicken: 4' x 5%'.
- We hope that this will give you the information you need. Note that
